2 To declare any interest in items on the agenda

Beckermet Play Park

The new play park at Beckermet would hopefully be open at the weekend following the pre opening inspection. An official opening would be held when the weather improved.

Thornhill Play Park

The park at Thornhill will cost more than the Beckermet park as there is more work to be carried out eg resurfacing etc. The village's children had chosen the play park design with their additional ideas also factored in. The updated design was handed out at this meeting for approval.

The funding application will hopefully be submitted in March with the work carried out in August 2023.

The Parish Council stressed again the importance of having volunteers from Thornhill to assist with local activities eg carrying out monthly inspections at the play park using the existing checklist.
